

NOTICE OF FORECLOSURE SALE

2. Instrument to be Foreclosed. The instrument to be foreclosed is the Deed of Trust dated 12/23/2014 and recorded in Book 524 Page 528 Document 300954 real property records of Kleberg County, Texas.

4. Terms of Sale. The sale will be conducted as a public auction to the highest bidder for cash. Pursuant to the deed of trust, the mortgagee has the right to direct the Trustee to sell the property in one or more parcels and/or to sell all or only part of the property. Pursuant to section 51.009 of the Texas Property Code, the property will be sold in AS IS, WHERE IS condition, without any express or implied warranties, except as to the warranties of title, if any, provided for under the deed of trust.

5. Obligations Secured. The Deed of Trust executed by GEORGE E. MONROE AND DELIA G. MONROE, provides that it secures the payment of the indebtedness in the original principal amount of \$156,000.00, and obligations therein described including but not limited to (a) the promissory note; and (b) all renewals and extensions of the note. Reverse Mortgage Funding, LLC is the current mortgagee of the note and deed of trust and CARRINGTON MORTGAGE SERVICES LLC is mortgage servicer.
