

NOTICE OF SUBSTITUTE TRUSTEE'S SALE

WHEREAS, on 5/13/2003, DAVID CANTU AND ADELAIDA G. CANTU, as Grantor/Borrower, executed and delivered that certain Deed of Trust, in favor of ELDON L. 
