In The Matter Of Discussing And Acting On Amending Original Community Facilities Application Submitted To The U.S. Department Of Agriculture To Include Relocation Of The Animal Shelter And Health Department

The above matter coming on for consideration, Judge Madrid addressed the court saying the City is canceling the Interlocal Agreement and is asking us to vacate within 180 days. King Ranch did Deed property to the City for City Health Department. We were

going to give the city and county a new facility but now that they are asking the county to vacate the county will be building their own animal shelter in Riviera. Commissioner Rosse said he would like something in writing from TCEQ and asked if we have done research on fees for service. Commissioner Rosse also expressed concern for residents who will be paying double for two Health Departments. Judge Madrid advised the Commissioners if any of them want to put a plan together for this he will discuss it with them. He went on to say he has worked on this for a month and no one other than Commissioner Schultz has helped. The Judge ended by saying if the County pays the City for fees of service the City will have full control of Human Health Department. Commissioner Schultz said an animal shelter in Riviera will be for Ricardo, Riviera, and Kenedy County. A motion was made by Commissioner Cantu and seconded by Commissioner Schultz approving to amend the original Community Facilities Application submitted to the U.S. Department of Agriculture to include relocation of the Animal Shelter and Health Department. Upon vote, Judge Madrid and Commissioners' Schultz, Cantu and Salinas voted age and Commissioner Rosse voted nay. The motion carried and so ordered.
