Will be increasing budget

Weaning department off Asset Forfeiture Funds

Eventually Asset Forfeiture Funds will come to an end

I want to use Asset Forfeiture Funds for emergencies NOT as a way to run/sustain my office

We can no longer rely on Asset Forfeiture Funds as a sole source

We have always been very generous with our Asset Forfeiture Funds and will continue to come through for the county

More storage is needed

Old files need to be digitalized

Estimate cost \$100,000.00

Will be asking the \$10,000.00 from the state

This will be a costly project but will be good in the long run

Increases to budget are as follows:

Up \$30,000.00

Increase \$17,000.00

Asking to pay secretary minimum wage out of county and the rest will be funded from Asset Forfeiture Funds

It was decided to cap the District Attorney increases at \$70,000.00 and any amount over that will be paid out of Asset Forfeiture Funds
