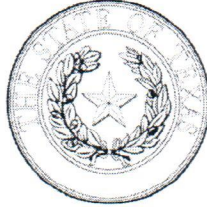


Kleberg County Commissioners' Court Minutes


In The Matter Of Discussing And Acting On An Order To Institute Emergency
Measures Due To A Public Health Emergency To Limit The Number Of Persons
Gathering To No More Than (50) Persons At Facilities Located Within Kleberg
County, To Include Grocery Stores, Designated Medical Facilities Or Other
County-Approved Facilities, And Issuing Penalties. (Judge)

The above matter coming on for consideration, a motion was made by Judge Madrid and seconded by Commissioner Schultz on acting on an order to institute emergency measures due to a public health emergency to limit the number of persons gathering to no more than (50) persons at facilities located within Kleberg County, to

include grocery stores, designated medical facilities or other county-approved facilities, and issuing penalties. Upon vote, the motion carried unanimously and so ordered.
