What is the process going to be?

Judge Madrid -

Protocol for Kleberg County if you suspect you have symptoms of the flu are as follows: 1. Contact Emergency Room / Health Care Provider

- 2. Go to staging area where you will be assessed
- 3. If you meet any of the criteria of COVID-19 you will be sent to Pan American for testing
 - 4. DHS (Department of Human Services) will be notified
 - 5. Test will be sent to Harlingen
 - 6. Results within 24 hours
 - 7. Notify individual

Hours of operation will be 8:00 am - 5:00 pm

Sheriff's Office will provide security at the site

Spohn Hospital has stepped up and will provide supplies

Commissioner Schultz -

Biggest concern is younger generation, they don't take it as serious How do we explain it to them so they understand the severity?

Commissioner Cantu -

Will this be a drive thru or will individuals go inside?

Judge Madrid -

It will be inside, no one will leave

No risk of contamination to Kleberg County

If after hours, Spohn Kleberg Hospital will make sure the patient will be there the next day at 8:00 am

Will go live with this as of Saturday

Thank you to all citizens of Kingsville for helping out or wanting to help. It is appreciated.
