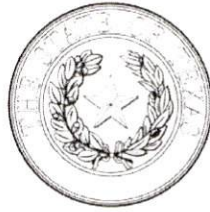


Kleberg County Commissioners' Court Minutes

PUBLIC COMMENTS :

Dr. Jose Ugarte :

Dr. Ugarte is associated with the County Jail. Over the past 20 years, the inmate population has changed significantly, bringing new challenges. Rising costs for generic prescriptions—particularly for conditions such as Hepatitis C—and the limited availability of medications like penicillin have added to these concerns. Dr. Ugarte is fortunate to have the support of the nurse, Ms. Bunch, who is dedicated and available seven days a week. However, there has been discussion about the need for a medical assistant to ensure coverage during times when she may not be available. One proposal is to train jailers to become medical assistants and transition staffing from 8-hour shifts to 12-hour shifts to better meet the facility's needs.
