#### **PUBLIC COMMENTS:**

Ofelia Villarreal, 627 E Henrietta, Kingsville, Texas: Ms. Villarreal represents the Santa Gertrudis Cemetery. Ms. Villarreal states there is a new board of which she is a member and has come to court today to ask the court if there is any way they could get a 350 gallon tank from them to use to for their fuel from Commissioner Martinez. The tank they have at this time holds only 50 gallons and the cemetery maintenance crew goes through it in no time. Commissioner Rosse stated he would have to refer this to the legal department as Santa Gertrudis Cemetery is not a county cemetery. Commissioner Rosse explained to her that Kira Talip-Sanchez would get with the Texas Association of Counties and see if the county can assist in any way.

Robert Zavala, 256 W CR 2170, Kingsville, Texas: Mr. Zavala is here today to speak on the environment in his area. Mr. Zavala states that he has lived out in the Ricardo area nearly all of his life. Growing up in the area he states they picked up whatever thrash they made. Now a days many of the county roads out there look like thrash drop offs. You can find tires, household items and what nots. Mr. Zavala is coming before the court to ask if there is any way they can get additional Sheriff Department units to patrol that area to try and catch the people that keep dumping in the area. Mr. Zavala also would like "NO DUMPING SIGNS" put up. Mr. Zavala suggested coming up with an agenda item to try and come up with a solution for all the dumping. He states that when the grass is mowed by the roads one can see thrash that is under the grass that just been mowed. Dumping laws and fines need to be stricter.

Commissioner Rosse made a second motion to request from Mr. Brando Harris reimbursement for the fuel that he charged against Kleberg County and give him a set time, seven (7) days to reimburse the county. The motion was seconded by Commissioner Martinez. All in favor signify by saying aye, all of the commissioners voted in favor of the motion, none opposed it. This will be back on the agenda at the next meeting in executive session so this can be followed by with the county attorney as to what direction we will go with this.

### • Conduct Any Other Business Necessary For The Proper Functioning Of County Business

A Resolution was brought forward by Commissioner Jerry Martinez to Honor the Vietnam Veterans. Resolution asks that March 29, 2025 be recognized as National Vietnam War Veterans Day. 970 Soldiers died the first day of the Vietnam War, 1,448 Soldiers died the last day of the Vietnam War. A total of 59,472 soldiers lost their lives during the war.

Commissioner Rosse made a motion for the county judge and the commissioners to sign the resolution, Commissioner Martinez seconded the resolution.

Pursuant to The authority granted under Government Code, Chapter 551, The Commissioners Court may convene a closed session to discuss any of the above agenda items. Immediately before any closed session, the specific section or sections of Government Code, Chapter 551 that provides statutory authority will be announced.
