Texas Wildfire Grants paid \$350,000.

Helen Groves/Robert Kleberg Grant pays out \$1.7M over 3 years.

Have been thinking of creating an Annual July 4th Festival at the Dick Kleberg Park. Would like to have a carnival, rodeo, car show, concert, Bar B Que Cook off Contest.

Ron Pray, Fire Chief/Fire Marshall requested shirts for uniforms for himself and would like to see if Frances could order some for him. Judge approved request for shirts.
