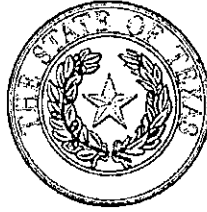


Kleberg County Commissioners' Court Minutes

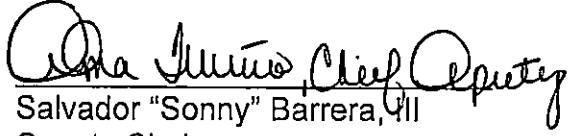
