COURT WAS OPENED and called to order by Commissioner to consider the following agenda items, Commissioner Schultz gave the invocation and Commissioner Salinas led the Court in the Pledge of Allegiance of the United States and Texas Flag.

#### **PUBLIC COMMENTS:**

Jose Perez, 416 E Lee, Kingsville, Texas 78363. Mr. Perez came before Commissioner's Court in regards to his taxes and street maintenance. Mr. Perez says he has been over charged on several occasions and when he asks questions he is given the run around and met with crappy attitude from the people working in the tax office. Mr. Perez says that he signed a contract to pay so much money monthly and every time he paid it showed different balances. Mr. Perez would like why this is happening and where is his money going. Commissioner Schultz asked him if he paid with a check and he said no as he liked paying with cash, but states he has his receipts. Judge Madrid asked to contact Victoria Valadez who is the Tax Assessor, to which Mr. Perez stated he had and she was to get back to him but she never has. Both Judge Madrid and Commissioner Schultz told him that they would assist him in getting to the bottom of all of this. Mr. Perez also brought up the fact that the streets are in bad condition and nothing is getting done with that either. Judge Madrid advised him that was a City issue and he would have to go to the City Council Meeting to get answers. He said they give him the run around also. Judge Madrid asked him to get in touch with Charlie Sosa the Interim City Manager and discuss the street issue with him.

Steve Jones came before the court to speak about an alarm system that could be placed in schools for added safety. Mr. Jones did a presentation of how the system works if used in a school or business. It has the option of downloading its software onto each employees' personal phone so as to alert them of a possible threat. Mr. Jones came to the meeting to do this presentation of Sheriff Kirkpatrick. The system is going to be set up at Riviera ISD for a trial run. This system costs \$3,500.00 per year.
