WORKSHOP SESSION Regarding Fiscal Year 2024-2025 Kleberg County Budget.

The above matter coming on for consideration, this motion was made by Commissioner Rosse and seconded by Commissioner

We talked about paying off some debt for Kleberg County and pushing more pennies into the MNO, so next year we can capture the MNO and build up a reserve as well. We got Ray DeLosSantos, in finance and Ray Tijerina working diligently and our Auditor's Office working their butts off to get us the a complete audit this week. We got a solution to all of this. I know you guys hate me for always saying there is no such things as problems only opportunities. We found a huge opportunity out of this tax oversight. We talked to our lawyers and some of the best financial advisors and the law clearly states we can only spend the money on debt.

Due to an error in Tax Assessor-Collector Department tax money that was collected was not entered into the correct account. It was placed in the debt column instead of the MNO column. It did rob our MNO of about \$1.8 million that would have been deposited into the reserves account. As it was placed in the debt column the money will need to be used to pay debts. The law states the money

can only be used to pay off debt. If it is not used in this manner Kleberg County can and will be penalized by the state. Kleberg County will pay off some of their debts and will acquire new debt to compensate for this error.

Every year when we set the budget I'm very conservative. We work on an anticipated budget. Anticipated revenues and anticipated expenditures. I upcharge our expenses and down charge our revenues. By doing this Kleberg County stays ahead of the game. This money can be used on immediate repairs. One unique way to also use this money is to use it to match grants. New Fire Stations come with a \$40K matching grant. We are building a new one in Baffin Bay and Ricardo and completely remodeling the one in Riviera. The new EOA Building comes with a \$300K matching grant. The Kleberg County Airport comes with a \$68K matching grant. Monies will also be used in building the new Rural Development Center that is being built. Once completed this venue will bring in Approximately \$300K in revenue.

JK Northway will get revenues that will pay for both the EOC and JK Northway once events begin using it more and more. As more events are booked at these facilities it will also bring in visitors that will be staying at our motels and hotels and dine at the different restaurants in our area

Oxy will be breaking ground in the next 6 months and that will be bringing in more residents and businesses to Kingsville.

The population in Kleberg County is going to continue to grow. The communities of Ricardo and Riviera will see a big change as people will be looking for land to buy and build their homes.

KISD scores have come in and they are extremely low. Kleberg County, City of Kingsville and KISD administrators and faculty will all be working together to help students bring up these scores.

A \$2 million dollar grant that had been awarded was never used so it has been placed back on the table. Kleberg County will be applying for it.

Krystin A. Gamez, Library Director—needs new Software on the computers in the library. States she has called Birdwell IT Services to install Microsoft and to date has not heard from them. With school starting there will be students using the computers and they need to be upgraded to meet their needs. Commissioner Schultz said he will contact Brian Birdwell in regards to this. A new website also is needed. Alternate payment methods are also needed to pay vendors in a timely manner. Many vendors are wanting payment at the time orders are being placed and in a timely manner. Using a P-card was brought up that it could be used but an approval to use is for the amount needed would have to be put in place. Commissioner Rosse also stated that this should be placed on the agenda for further discussion at Commissioner's Court.

Ms. Gamez also commented that her salary is below what other librarians are paid. Ms. Gamez asked that Commissioners' Court consider a pay raise for her. Ms. Gamez has been with the library for two (2) years and has brought changes to the library as a Children's Corner.

Maintenance Department—Ray De La Garza would like to promote Mr. Velasco from a custodian position to Foreman and pay him \$20.00 per hour. Mr. Velasco would take charge whenever Ray is out for a few days. This will be considered at the time the budget is determined.
