COURT WAS OPENED and called to order by Kleberg County Judge Rudy Madrid to consider the following agenda items, Commissioner Schultz gave the invocation and Commissioner Rosse led the Court in the Pledge of Allegiance of the United States and Texas Flag.

PUBLIC COMMENTS:

Roy Cantu, 303 Elm, Riviera, Texas 78379

Former Commissioner Cantu came before the court today stating that he had received a call from a concerned citizen of Riviera in reference to the Volunteer Fire Department. Commissioner Cantu states there are only 2 volunteers at this time to handle calls in and around Riviera. Both of these persons are employed during the day so there is no one available out there if a fire breaks out during the week. Commissioner Cantu found a FEMA Grant called the Safer Grant. This grant provides funding for staffing, training, maintaining and also offers pay to firefighters as an incentive. People applying for this program will be fully trained as firefighters when they complete the training.

First year of grant provides 100% for staffing, training and maintaining a Fire Station. The second year provides 80% and will continue dropping until the 6th year at which time the grant stops all assistance.

Judge Madrid thanked Commissioner Cantu for his presentation and said he was going to look into this grant as the he has been wanting to upgrade the station in Riviera and to build new ones in Ricardo and Baffin Bay.

Ms. Zavala's Department will be hosting a 5K and 1K event on Friday, August 16, 2024 at the Maggie Salinas Pavilion, 206 E. Yoakum. The 1K will begin at 7PM and the 5K at 7:20PM. Ms. Zavala is requesting assistance as follows:

- Hosting water station at the west entrance of the courthouse at the corner of 11th
 Street at Kleberg Street. As there is construction going on at this time
 in the area another site will be proposed.
- Will need to use the metal barricades from JK Northway.
- Assistance with marketing this event.

Texas A&M Agrilife assists both Kleberg and Kenedy Counties in promoting healthy living. Along with the 1K and 5K events there will also be entertainment, health screenings, healthy food treats and they will be promoting physical activity.

Roads are to be built to County of Kleberg specifications. Land owners will need to take care of roads for up to 5 years, at which time Kleberg County can decide to take over maintenance of roads. All half (1/2) acre tracts and one (1) acre tracts must have septic tanks and water wells. Developer will be responsible for drilling a water well, have the water tested and guarantee for 30 years. City of Kingsville Health Inspector Emilio Garcia has been out inspecting new additions to ensure that all regulations are being followed. Upon vote, the motion carried unanimously and so ordered.

Mr. Tijerina will look into the debts Kleberg County has and make suggestions as to which debts could be paid out. Upon vote, the motion carried unanimously and so ordered.
