Convene Into Public Hearing on Kleberg County Tax Increase for Tax Year 2024.

A. Open Hearing

County Judge Madrid opened hearing with the statement that we would not have tax increases. Tax Assessor Victoria Valadez was in attendance and he verified with her. Judge Madrid thanked the Tax Assessor Collector office, Auditor's office and all of the County Commissioners as we have worked hard this year to keep from having any tax increase. He also thanked all Kleberg County employees as they deserve all the credit because of all their hard work we can still see million of capital improvements that cost the taxpayers little to nothing. At the end of the day according to our outside audit we still made over \$2.3 million dollars after everything was said and done. It was a great year for Kleberg County. I think next year it is going to be even better. Commissioners Court Member's Comments

B. Commissioners Court Member's Comments

Commissioner Rosse said he has stated over and over again the years that he wishes the county could give some relief to the taxpayers. As the auditor tells us we are in such good shape and how much is in the bank I would really like to give some back. As some of our taxpayers are barely making it and would appreciate the extra help. So many of our taxpayers are on a fixed income and do not have the benefits that others do. Judge Madrid but twelve (12) years ago before this administration took office almost every year taxes were going up and we stopped that. We corrected our budget and in fact we reversed it. We started investing wisely. We started investing in capital improvement projects that only make up revenues at little to no cost to the taxpayer and we are seeing growth now in Kleberg County. Kleberg County is building a lot of stuff out there. There is still a price to run the county, the Sheriff's Office, Human Services, Meals on Wheels, the courthouse, every single county building out here. We see inflation as everyone else does. I think it's fair to say that whenever we see tax increases in Kleberg County, it's always the City and the Appraisal District. If I had my choice I would take Kleberg County Appraisal District off of it as people get confused as they think it's us. They are an independent entity, that just happens to be in Kleberg County. Because the Appraisal District

has been so high on us and beating us up pretty good that I make it a point that we work diligently and I have to give Melissa Green all the credit as she works with me on making it fit. We have all these things we want to do and we need to make sure that everything fits as we don't make to increase taxes but at the same time we need to make our county safe. The state still requires that we keep "X" amount of dollars in reserves in case of a rainy day or God forbid a pandemic comes or hurricane comes or a fire, you have to be prepared, you can't leave your community at risk. Commissioner Rosse states he understands that but I think our taxpayers deserve a little more.

Judge states there will be two (2) new fire stations built, one in Ricardo and out on Baffin Bay and the one in Riviera will be completely remodeled.

We won a big grant that is going to help with a \$10 million dollar drainage project in Ricardo that will elevate the drainage issues in Ricardo.

We are building new regional training facility right on the highway that is going to support 2600 or more jobs going into play and that's a huge deal for our school districts both at the high school and collegiate level. We just built an Emergency Operations Center. We are going to put in a Regional Fire Training Center. We are also building a Business Incubator Center to help small businesses get off their feet. There is a lot of neat stuff coming.

It's a collective effort, that's why we are able to give every employee a decent raise to all of our employees.

Commissioner Schultz states one of ways we can benefit our citizens is by better roads in the county. Our road system is not working as it should be. If you want to give relief to the citizens, think about the roads.

I think we all agree that when Oxy gets here we will be in a unique position where we have to acquire debt and in order to offset the interest in this. This goes back to the Old Boston Tea Party, no taxation without representation. We got to show the taxpayer that we are going to be collecting all this excess from Oxy and 1.5, how can you continue to tax the taxpayer when we have all that outside money? I think we have all agreed the roads and bridges in Ricardo and Rivera ae to be our main focus. My thoughts are that we just hire out an independent company such as Bay. You Commissioners figure out what are the 50% of roads need it most and just hit the ground running, do them all at one time, do nothing but road and bridge, do them all at one short, do nothing but road and bridge. Take out a bond out against that, acquire some debt and put that money in the right spot. Money that we didn't have that belongs to the citizens. You talked about giving back to the citizens, that's going to be a big one. That's something the City can't do but we are doing it.

He has contacted Bill Donnell with the City of Kingsville and made a donation to the city of about 25 loads of millings. The millings will be used in the alleys and other necessary roads. The millings that are being donated to the City are out by Pan American College.

Commissioner Rosse said that was to be paid by the seller. Ms. Cantu added that Victor with S&S Title Company had worked on this project. Judge Madrid called Victor but was unable to contact him, he then called the title company and spoke to Anna Lisa who explained the difference in the price. The difference stems from adding the following to the \$493,680.00. Closing Fee \$500.00, owner's title insurance \$2,907.00, State of Texas guaranty fee \$2.00, Kleberg County Tax Certificate \$10.00, Kleberg County Clerk filing fee \$53.00. County has been given credit for earnest monies \$1,000.00 and county taxes \$27.50. Upon vote, the motion carried unanimously and so ordered.
