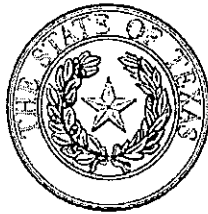

The above matter coming on for consideration, a motion was made by Commissioner Rosse and seconded by Commissioner Schultz to act on receiving two (2) RFP bids for Grant Writing and Administrative services for the 2025-2026 TxCDBG Grant Program as administered by the Texas Department of Agriculture. One bid was from Lankford Community Management Services from Liberty, Texas. The second bid came from Grantworks, Inc. from Austin, Texas. The bid from Lankford Community Management did not have a dollar amount anywhere on it. Tim Weatherby with Grantworks, Inc. stated the amount of the grant was \$500,000.00 but had been raised to \$750,000.00. This is a time sensitive grant, Andurra and Donnie Hubert have assured the Kleberg County that they will meet the deadline. Based on cost, Lankford Management Services is charging 10% compared to Grantworks Inc. 7.1 %. Hoss Castillo states these funds can also be used to make hook-up from septic tanks to waste water sewer lines. After much discussion Commissioner's Court liked the bid from Grantworks, Inc. Upon vote, motion carried unanimously, and so ordered.

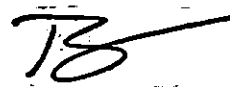
