### Workshop Session Regarding Volunteer Fire Department.

**Judge Madrid:** Did all the Fire Department get the message we were having a meeting today? Where are we at with all of that?

**County Attorney:** What it's coming down to is trying to figure this out. I did ask for Articles of Appropriation and have not received any, I am trying to figure out how to do the contract so we can move forward, that is the issue.

**Commissioner Rosse:** It is my understanding the only ones who have registered with the state is Riviera Volunteer Fire Department, is that right?

County Attorney: Yes, they are here and they did submit their Articles of Incorporation, I don't' believe they have their 501C3 which they would also have to submit.

**Jacob Mosley:** That could be expedited through the IRS. It's not necessary to register with the state.

**Adam LaRosa:** It is not necessary to register with the state. A 501C3 is not required in our province.

**County Attorney:** They do have their Articles of Incorporation, but I do feel it is important we do have someone from the county that can be designated to be able to have access to everything that is going on with the employees, not in charge, but someone who can make sure the contract is being followed. A new contract needs to be written up.

**Commissioner Rosse:** For liability purposes, you don't want to be in control because then it would expose the taxpayers of this community to, by my understanding, it would expose Kleberg County to potential liability, is that right?

County Attorney: Yes, but we can designate someone that is going to make sure our interest is being covered as we are the ones funding everything. The buildings, the equipment, everything is being funded by Kleberg County but they are their own entity, that's why we have to re-write the contract. That's why it would say that at the beginning of each year we can audit everything, we can have our designee come in and out as they want making sure everything is being done correctly. They should be giving us proof of their Articles of Incorporation every year before we give them their funding. Judge Madrid: Certifications, training.

**County Attorney:** Certifications, training that is required and all of that will be in the contract and they have to show us that before the funding is given every year.

Rosse: It would be my suggestion to authorize the County Attorney to work up a contract between Kleberg County and Riviera Volunteer Fire Department for the operation of fire protection in Kleberg County. Having said that I would suggest that it be, the first (1st) initial, six (6) months that we would evaluate in the first (3) months and then six (6) months to make sure Kleberg County's interest is covered and at the same time there is fire protection in the county. Right now anything south of 772 is not covered. There is no coverage down there and we have to make sure we have fire fighters throughout the county.

JP Chris Lee: So we are splitting again?

County Attorney: As of the last few years the funding is for both together.

JP Chris Lee: I understand that, what you are saying we are going to split again

Commissioner Rosse: No, Riviera will be

Judge Madrid: What I see happening and this is the way I see it, and I have listened to the legal advice given to Kira, what I see is happening is that will be the Riviera Fire Department Station I and II. I think it's all going to fall under Riviera now because they are the only ones that are incorporated to the State. There is no Kleberg County Fire Department Station I and II. We have looked at it a thousand different directions, we are just trying to it the legal way. There are options that were offered to us that we. are not interested in. The county wants to run their own, no, we are not interested in doing that. Do we want to continue to fund it and have a designee, who is a designated supervisor on behalf of the county to ensure all the financials are in order and to ensure all is done in accordance with State and Federal laws basically, which we are allowed to do as we have a vested interest in it.

**Commissioner Rosse:** And I mentioned six (6) months, but if there is no objections then it would automatically roll to continue, so we are not continually doing this.

Judge Madrid: Just do a status hearing in six (6) months, do evaluation.

Commissioner Rosse: This evaluation is just to see where we are at, what we can do better just to get fire protection out in the county.

**County Attorney:** If you would allow me to meet with them, first to go over possible contract firsts, I already have an idea about all that we need in it so it will be a matter of getting that done.

**Judge Madrid:** I know the auditor wants the back cleared up. Commissioners have concerns about vehicle usages and things of that nature. There need to be clearer guidelines on when and where to use those vehicles. Just need to tidy up the books here and we can help with that.

**Commissioner Rosse:** Because it says Workshop Session, can we vote on that? **County Attorney:** You can discuss it.

**Commissioner Rosse:** My motion will be to authorize you (County Attorney) to work with them to get that contract worked out and bring it back to the court, and that is my motion.

**Judge Madrid:** So County Attorney, just for clarification, will work with fire department, put together a contract and bring it back to Commissioner's Court for review and approval. We have a motion on that, do we have a second?

Commissioner Martinez: That only includes Riviera, not Ricardo?

**Judge Madrid:** The contract right not for all practical purposes, nothing changes right now. The dates of operation is going to stay as is right now. Once they all agree on the contract it will have an effective date on it. My only expectation is that we do have a county representative involved here.

County Attorney: You will have to designate that person.

Commissioner Rosse: That will be part of the contract.

**County Attorney:** It will be part of the contract, that the county has a right to designee, it does not have to have desginee's name on it.

Commissioner Schultz: Riviera Fire Department I & II.

**County Attorney:** It's just a title, just like it was Kleberg County Fire & Rescue. But if it is not a valid entity it does not matter what the name of it is, the 2 buildings are still the county's, the equipment, then Station I and II

Judge Madrid: Sounds good to me.

**Commissioner Rosse:** Would it be appropriate now that the motion has been made and seconded if they have any question and comments.

Commissioner Schultz: I don't think that it's been seconded. Did someone second it?

Commissioner Rossi: Yes Commissioner Schultz: When

Commissioner Rosse: I thought Marcus had.
Commissioner Martinez: You seconded it?
Commissioner Salinas: I'll second it, I got you.

**Judge Madrid:** The only thing that needs to be put in that contract, is, I do understand that in order, you are not required to have a 501C3 but you do need to know that if you do have fund raising activities for the fire department, you will have to get one for that.

Adam LaRosa: We have every intention of obtaining one.

**Commissioner Rossi:** Adam come to the podium and repeat your name for the County Clerk.

Adam LaRosa: We have every intention of obtaining a 501C3 that we have actually been working on that. The only thing that I was speaking about was that it was not a requirement to register the entity within the state.

Judge Madrid: That's good.

Adam LaRosa: Fund raising efforts will be included with that as well because we don't

want to be completely dependent on the county if not entirely necessary.

Commissioner Schultz: There's lots of county's that don't give any monies to the Volunteer Fire Departments.

Adam LaRosa: There has been a lot of breakdown in the practices within Kleberg County Volunteer as it pertains to the Volunteer Fire Department, so as a result of that we are going to be starting from the ground up unfortunately, and this is our first step towards that.

Commissioner Schultz: Absolutely, get all the help you can get. Does anyone have anything to air out there?

Judge Madrid: Alright, is there any other business for the court?

Commissioners: We need to vote.
